Dear Residents and Families/Representatives,

As of today, our facility continues to be proud to report no confirmed cases of COVID-19. Our staff continues to practice the enhanced safety precautions we have previously reported to you through our website and we are closely monitoring the recommendations of our federal, state and local health officials regarding all aspects of COVID-19 from mass testing to visitation recommendations.

In fact, as New Mexico loosens COVID-19 restrictions throughout the state, many people are asking when they will be able to visit their loved ones. At this time, the Centers for Medicare and Medicaid Services ("CMS"), the Centers for Disease Control ("CDC") and our state health officials are still requiring we restrict social visitation and only allow essential personnel in the facility. Please understand these restrictions are in place to reduce the risk of transmission of COVID-19 in our facility and to keep our residents safe. The New Mexico Department of Health is discussing plans to slowly lift restrictions, but at this point has not provided further guidance on a formal date or plan.

We understand how difficult it has been to not see and visit your loved ones over the past several months and we appreciate your patience and understanding during this time. Until it is safe to allow visitors, please remember that we encourage you to stay in touch with your loved ones through FaceTime, emails, letters and phone calls. Please let us know if you are having trouble connecting with your loved one and we will be more than happy to facilitate your communication.

Please remember to check our website for updates. As always, we will notify you if we receive confirmation of a new positive case in our facility and we will reach out to you individually if your loved one is displaying symptoms of COVID-19 or tests positive for COVID-19.

## **WEEKLY UPDATE**

**June 4, 2020**

Dear Residents and Families/Representatives,

Please accept this letter as our facility's weekly update to keep you informed about the status of COVID in our facility and what we are doing to keep our residents and staff safe during the ongoing coronavirus pandemic.

There have been no additional confirmed cases of COVID-19 in our facility since we notified you of our only case as of May 19<sup>th</sup>. At this point we are happy to report that the contract staff member that initially tested positive tested negative 4 days later. We have completed 100% testing of staff and residents with no further positive cases. We will continue routine testing of staff and patients until further direction is received from NMDOH. I am also pleased to inform you that through a partnership with New Mexico Department of Health, Clean Harbors has been contracted and has provided a facility wide sterilization on Monday June 1<sup>st</sup> and 2<sup>nd</sup>, 2020. We have continued deep cleaning the facility with the appropriate solutions to combat Covid-19 as well. We have continued to have one on one activities with Casa Maria's residents and social distanced activities in very small groups.

I would like to take a moment to address our most common question relating to whether Casa Maria will allow visitors as New Mexico continues to reduce restrictions. We will follow the recommendations of our state health officials and at this point no visitation restrictions have been lifted. The New Mexico Department of Health is discussing plans to slowly lift restrictions, but at this point has not provided further guidance on a formal date or plan.

We remain committed to protecting our residents and staff and preventing further spread of this virus. As we previously reported, we will continue to implement and practice enhanced safety precautions recommended by our federal, state and local health officials, such as, only allowing essential personnel inside the facility, not allowing outside items to be brought into the facility, performing regular screenings for signs and symptoms of illness prior to entering the building, continually monitoring residents, performing regular deep cleanings, using PPE as recommended by the CDC, providing individual activities as opposed to group activities, implementing isolation protocols as required, and reminding and encouraging staff to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community.
